

SKILLS INTENSIVES

Throughout the year, the Institute offers intensive training for agencies looking to start or retool their shelter program. Current offerings include Emergency-Stabilization, Restorative Care and Minor Care. Scholarships may be available. We offer a robust online learning management system with 80+ courses on topics specific to shelter care. Courses are taught by shelter practitioners and topical subject matter experts.

WEBINARS

We host free and fee-based monthly webinars on contemporary topics for shelters and affiliated agencies.

INDUSTRY SURVEYS

Approximately 4x per year, we conduct a survey of the shelter landscape on topics of contemporary interest. These reports provide decision-support to shelter leaders and funders. All of our reports are offered free to the landscape and the general public.

In response to shelters' needs to track survivor progress and outcomes, the Institute customized a state-of-the-art case management tool for trafficking, including standard intake forms, releases, assessments, and progress markers, at a discounted rate for shelters. This tool is being deployed in shelters nationwide.
